
# Modification-I In Distribution Licence of IESCO (No. 01/DL/2001, dated November 02, 2010)

#### (A). Article 3

- (i). A new clause (d) in Article 3.2.(i) is inserted in the Distribution License of IESCO as under:-
  - "(d) an area served by the Bahria Town (Pvt) Limited (BTPL) as given in the Schedule III of the license."

#### (B). Addition of Schedule-III

(i). Schedule III detailing the territory of BTPL is added in the Distribution Licence, covering Bahria Town Phase I to VII, Bahria Paradise and Safari Villas I & II.
