

**CORRIGENDUM**

**DETERMINATION OF THE AUTHORITY IN THE MATTER OF UPFRONT GENERATION  
TARIFF FOR SOLAR PV POWER PLANTS DATED 22-01-2015**

Following corrections have been made in the decision of the Authority issued vide No. NEPRA/UTS-01/905-907 dated January 22, 2015 in the matter of upfront tariff for solar PV Power Plants:

1. Under Para 14(I), page 45 in both tables under last column:
  - i. In Row 3 "US\$/PKR" may be replaced with "PKR/US\$"
  - ii. In Row 5 "US\$/PKR & LIBOR" may be replaced with "PKR/US\$"
  - iii. In Row 6 "US\$/PKR" may be replaced with "PKR/US\$ & LIBOR/KIBOR"
2. In Para 14(II)(i), page 45-46 in 6<sup>th</sup> line after the word "values" the following words may be deleted:

"except the discount on EPC cost. The amount of discount, if available to any project will be accounted for and EPC cost will be adjusted downward"
3. Under Para 14(V)(xx) of Terms & Conditions in line 4 after the word "tariff" the following may be inserted:

"except as provided under Para 14(II)(ii)"

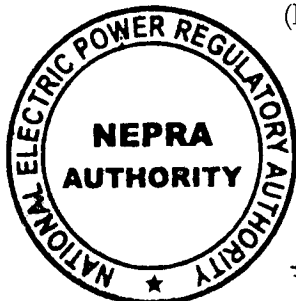
