



**PROJECTS DATED JULY 7, 2015**




- i. On page 11 under the heading "Adjustment of debt servicing component" the figure 7.99%, wherever appearing, shall be replaced with the figure 9.50%.



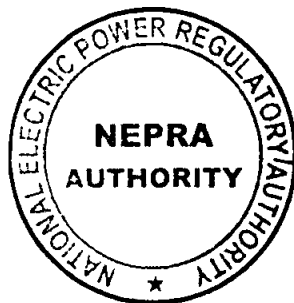
