All stakeholders, interested / affected persons and the general public are notified that the Authority has admitted the application of Packages Power (Private) Limited (PPL) for consideration of grant of Generation Licence for its proposed Hydro Power Plant at District Kasur.

Introduction of Applicant:** PPL is a Private Limited Company incorporated on October 20, 2016 under Section 32 of Companies Ordinance 1984 (XLVII of 1984) vide Corporate Universal Identification No. 0102957. The Business Office Address of the company is Sharah-e-Roomi P.O Amer Sidhu, Lahore. According to the Memorandum of Association, the objects of the company, *inter alia*, include business of power generation.
