STATEMENT OF THE REASONS IN SUPPORT OF THE MODIFICATION:


- 1. Due to non-availability of Indigenous Natural Gas now-a-days as informed by SSGC. The Ministry of Energy (Power Division), being awareness of the electric power demand has decided to make arrangement of RLNG through Ministry of Energy Petroleum Division GOP for GENCOs Plants including JPCL's Plants too; so that RLNG could be utilized as a cheaper fuel for operation. It is further added that National Power Control Center Islamabad (NPCC) being System Operator is also discouraging operation on Furnace Oil keeping in view of their Economic Merit Order (EMO).
- 2. The same existing infrastructure of Indigenous Natural Gas will be used for RLNG for operation of TPS Jamshoro Units (ST-2 to ST-4) and GTPS Kotri Units (GT-3 to GT-6) as both Indigenous Natural Gas & RLNG are predominant methane gas having same specifications as informed by SSGC.
- 3. The gross heating value will be 950~1050 Btu / Cft and supply pressure at the delivery point will be 50 PSIG or 4 Kg/cm² i.e. same like Indigenous Natural Gas.
- 4. There will be no impact on operational parameters including net capacity, auxiliary consumption & net thermal efficiency on account of utilization of RLNG; because of same specifications like Indigenous Natural Gas.
- There will be no impact on annual availability along with outages, annual plant capacity factor and frequent start/stops etc. on account of utilization of RLNG; because of same specifications like Indigenous Natural Gas.
