Subject: **RENEWAL / EXTENSION OF DISTRIBUTION LICENSE NO. 02/DL/2002**

In exercise of the power conferred upon the National Electric Power Regulatory Authority (NEPRA) under Section-26 of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997 (XL of 1997) the Authority hereby granted Distribution License No. 02/DL/2002, on March 02, 2002 for 20 years to Faisalabad Electric Supply Company (copy attached as Annex-A).

The license is going to expire as on March 01, 2022. As per NEPRA Licensing Procedure Regulations, 2021 Part IV, under Rule 13 Extension or Renewal of Terms of License, the licensee shall produce the following information to the NEPRA.

- a) FESCO requires the extension in Distribution License.
- b) Proposed time period of extension is 20 years starting from March 02, 2022 to March 01, 2042.
- c) A statement of reasons in support of the extension:

License is going to expire as on March 01, 2022. As Licensee, FESCO is operating in 08 Districts having 05 Operation Circles with 26 Operation Divisions, 01 Construction Circle having 04 Construction Divisions, 01 GSO Circle having 05 Divisions, 01 GSC Circle having 01 Division and 01 M&T Circle having 05 Divisions, serving the 4700177 consumers of different categories. Moreover, Licensee has total No. of 116 Grid Stations with total No. of 118342 Distribution Transformers having distribution capacity of 8766 MVA over 1180 Feeders (detail attached as Annex-B).

However, it is in the interest of consumers and the Electric Power Industry as a whole and it is reasonably necessary to ensure the continuous, safe and reliable supply of electric power to consumers.

- d) Application fee as set out in Schedule-II of these regulations for Distribution Company is Rs.2,594,671/- (Draft attached as Annex-C).
- e) Board resolution of the company (attached as Annex-D)
- f) An affidavit regarding the correctness, authenticity and accuracy of the application documents and information (attached as Annex-E).
