As per Ministry of Energy (Power Division)'s Letter No. TARIFF/XWDISCOS-2022 dated 16th October, 2025 (copy attached), GEPCO acknowledges the Federal Government's approval to revise the annual tariff determination schedule, making the rebasing of electricity tariffs effective from 1st January each year. GEPCO also notes that the Authority has already determined the Power Purchase Price (PPP) references up to June 2026, and that references for the remaining period up to December 2026 have been submitted to the Authority.

It is also submitted that the honorable Authority, acceding to our request vide No. 2360/CFO/CPC dated 23.05.2025, has already allowed interim tariff for FY 2025-26, i.e. from July 1, 2025 to June 30, 2026.

In view of the foregoing and considering the PPP references up to December 2026, the honorable Authority is respectfully requested to kindly consider and issue the tariff determinations for the extended period up to December 31, 2026 so as to ensure seamless transition and facilitate the commencement of annual rebasing with effect from January 1, 2026.
