MULTIYEAR TARIFF (MYT) PETITION FILED BY MEPCO FOR THE 2025-26 TO 2029-30 & REVISION OF ANNUAL REBASING TIMELINES FOR CONSUMER END TARIFF

In pursuance of above, it is apprised that MEPCO filed its MYT for FY 2025-26 to FY 2029-30 for annual rebasing of consumer end Tariff under NEPRA Tariff Standards & Procedure Rules 1998 read with Part-5 of the NEPRA Consumer End Tariff Methodology and Process 2015 wherein the Annual Rebasing has typically been notified in July & stood effective from 1st July each year.

MEPCO filed for interim relief vide No. FDM/BS/B-1/12910 dated: 26.05.2025 and Regulator accordingly decided while giving interim relief for FY 2025-26 vide No. NEPRA/R/ADG(Trf)/TRF-624&TRF-625/9305-11 dated: 23.06.2025.

As per MYT true-up mechanism, MEPCO requests to allow true-up & Prior Year Adjustments (PYA) for FY 2024-25 amounting to Rs.113,848 Million (Detail attached as Annex-A) alongwith statement of Comparison of request and interim relief given for perusal and favorable consideration at Annex.-B.

The Federal Cabinet has approved the revision of the Annual Tariff Determination schedule so that the rebasing takes effect from 1st January each year. In view of above, MEPCO requests to issue Tariff Determination for the period from July 01, 2026 to December 31, 2026 to ensure smooth transition of revision in Annual rebasing from January 01, 2026.

Therefore, it is requested to issue Tariff Determination for six months i.e July, 2026 to December, 2026 as per NEPRA Consumer End Tariff Determination Mechanism and the request in the MEPCO MYT for FY 2025-26 to FY 2029-30 along with Annex/Addendum.
