SUBJECT: REVISION OF ANNUAL REBASING TIMELINES FOR CONSUMER-END TARIFF.

Reference: Ministry of Energy (Power Division) letter No. TARIFF/XWDISCOS-2022 dated 16.10.2025

It is intimated that the Federal Cabinet has approved the revision of annual tariff determination schedule so that the rebasing takes effect from 1st January each year instead of 1st July to enhance consumer affordability and ensure sectoral sustainability, the timing of annual rebasing has now been shifted from the summer to winter months when electricity consumption is relatively lower and any tariff adjustment can be better absorbed by consumers, which is endorsed by Section Officer (Tariff) Ministry of energy (Power Division) vide above referred letter. The Ministry of Energy (Power Division) has directed to formally approach NEPRA with the request to issue the tariff determination for the period from July 1st 2026 to December 31st 2026.

Therefore, it is requested to issue the tariff determination for the period from 1st July 2026 to 31st December 2026 that will ensure a seamless transition and facilitate the commencement of annual rebasing with effect from January 1st 2026.
