**S.R.O. \_\_\_\_\_ (I)/2025.** In exercise of the powers conferred by section 47 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (Act No. XL of 1997) read with all other enabling provisions thereof, the National Electric Power Regulatory Authority hereby notifies the following amendments in the National Electric Power Regulatory Authority Licensing (Application, Modification, Extension, Cancellation) Regulations, 2021.-

1. In Schedule III, after the list of documents contained under category D (ELECTRIC POWER SUPPLY), a new category E (ON-SITE SUPPLY) shall be inserted, with the following.-

**“On-site Supply:**

- \*1. Detail of Bulk Power Consumer(s) including name(s), location, load, other source of supply if any, etc.

- \*2. Relevant feeder maps and connection arrangement with the Bulk Power Consumer(s).
- \*3. Demand and consumption pattern on different time periods.
- \*4. Source of Electric Power.
- \*5. Training and development procedures and manuals.
- \*6. Information relating to:
  - \*i. Billing and collection procedures (including provisions for remote metering).
  - \*ii. Ability to access consumer metering systems and other services/equipment.
  - \*iii. Emergency provisions and protocols.”
