S.R.O. \_\_\_\_\_(1)/2016: In Exercise of the power conferred by Section 47 of Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (NEPRA Act) and sub-clause (a) of sub-section (3) of section 7 thereof, read with rule 3(2)(g) of NEPRA Tariff (Standards and Procedure) Rules, 1998, the National Electric Power Regulatory Authority (NEPRA) is pleased to approve the following amendments in the National Electric Power Regulatory Authority (NEPRA) Upfront Tariff (Approval & Procedure) Regulations, 2011 notified vide SRO 757 (1)2011 dated August 11, 2011, namely:-In the aforesaid regulations, —

- (a) in regulation 2, in sub-regulation (1) clause (b).
  - (i) the words "who is issued letter of intent/letter of support by any relevant agency" shall be omitted;
  - (ii) the words "National Transmission and Despatch Company/ Central Power Purchasing Agency" shall be substituted with the words "Central Power Purchasing Agency (Guarantee) Limited";
- (b) in regulation 4, in sub-regulation (3) clause (iv), after the words "the relevant agency", a comma shall be inserted which shall be followed by the words "wherever applicable";
- (c) in regulation 4, in sub-regulation (3) clause (v), the words "Central Power Purchasing Agency (CPPA)" shall be substituted with the words "Central Power Purchasing Agency (Guarantee) Limited (CPPA-G)".
