*Islamabad, the 28th May, 2013*

**S.R.O. 562 (I)/2013.**—In exercise of power conferred by Section 47 of the Regulation of Generation, Transmission and Distribution of Electric Power Act (XL of 1997), the National Electric Power Regulatory Authority is pleased to approve the following amendments in the National Electric Power Regulatory Authority Licensing (Procedure for Filing Appeals) Regulations, 2012, notified *vide* S.R.O No.1264(I)/2012 dated 09th October, 2012 with immediate effect:

After sub-regulation (1) of the Regulation 7, sub-regulation (2) shall be added as under:—

(2) The appellant shall also provide information provided in Form-D to these regulations.

2. Following Form 'D' to be added in the 'Schedule' of the Regulations:

## SCHEDULE

**Form-D (to be filled by Appellant)**

- i. Date of Issuance of order against which the appeal is filed.
- ii. Mode of delivery of the Order to the appellant.
- iii. Date of receipt of the order by appellant alongwith evidence
- iv. Whether this decision given with the consent of the parties?
- v. Whether the decision against which appeal is filed is interim order?
- vi. Whether appeal is being filed within 30 days of receipt of the order by the appellant, if not reason thereof?
- vii. Whether appeal is being submitted on prescribed format (Form A, B,C & D) of the Regulations?
- viii. Mode of delivery through which appeal is being sent by the appellant
- ix. Whether appeal is addressed to Registrar NEPRA?
- x. Whether affidavit duly signed by appellant, verified by Oath Commissioner is attached with the appeal?
- xi. Whether appeal is :
  - Typed-written and legible
  - Written on one side of the paper
  - Typed on good quality of paper
  - Typed on legal paper
  - Typed in double space
  - Whether all sheets are stitched together
  - Whether every page is consecutively numbered
- xii. Whether four sets in a paper book are submitted?

- xiii. Whether memorandum of appeal filed concisely under distinct heads?
- xiv. Whether grounds of such appeal are numbered consequently?
- xv. Whether certified copy of order against which appeal is being filed is attached with every copy of the memorandum?
- xvi. Whether written authorization in favour of signatory of the appeal is attached in case appellant or respondent is representing by his/her representative?
- xvii. Whether fee of Rs. One thousand (1000/-) in form of bank draft in favour of NEPRA is enclosed.

Other contents of the S.R.O No.1264 (I)/2012 shall remain un-changed.
