NOTIFICATION

Islamabad, the 19th day of June, 2025

S.R.O. 1098 (I)/2025. In exercise of the powers conferred by section 47 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (Act No. XL of 1997) read with all other enabling provisions thereof, the National Electric Power Regulatory Authority hereby notifies the following amendments in the National Electric Power Regulatory Authority Licensing (Electric Power Suppliers) Regulations, 2022 (hereinafter referred to as "the Regulations").

In Regulation 9 of the Regulations, sub-regulation 9 shall be substituted as follows:

"(9) An electric power supplier may sell electric power to another electric power supplier through a bilateral agreement:

Provided that in case a supplier of last resort sells electric power to another electric power supplier, the rates, charges and terms and conditions of sale, except for settlement of imbalances which shall be in accordance with the Market Commercial Code, shall be approved by the Authority:

Provided further that the procurement of electric power by a supplier of last resort shall be in accordance with the Applicable Documents."
