Reference is made to the public hearing held on December 19, 2023 regarding the subject matter.

2. The Authority has approved the following amendment in Consumer Service Manual (CSM) - 2021 in accordance with provisions of NEPRA Act and other enabling rules and regulations regarding extension of due date for payment and installments of electricity bills:

Sr.#	Description
	CHARGING OF MARKUP: If the request for installment of the current month's bill is made then:
1.	 i. There shall be no markup or LPS if first installment is paid within the due date. ii. The remaining installments shall be paid with markup @ 14% (per annum) on pro-rata basis.
	 iii. This facility of installment shall be allowed only one time in any financial year. iv. The request for extension in due date for payment of bill shall be made before the due date. v. The DISCO shall generate computerized bills upon allowing installments and extensions in due date.

3. All DISCOs including K-Electric are directed to implement the above amendment(s) in true letter and spirit with immediate effects. Further, the DISCOs and K-Electric are directed to place the above amendments on their websites along with the Consumer Service Manual.
