ADDENDUM/CORRIGENDUM

1- AMMENDMENTS:

The following amendments and clarifications are hereby issued in reference to **Tender No. 12**. This addendum/corrigendum forms an integral part of the original tender document. All terms and conditions of the original tender document remain unchanged, except as modified by this addendum/corrigendum.

i. Extension of Bid Submission Deadline:

The bid submission deadline has been extended. Bids, prepared in accordance with the instructions given in the tender documents, must now be submitted through the e-Pak Acquisition and Disposal System (e-PADs) on or before 15th October 2025 at 1400 hours. The proposals will be opened on the same day at 1430 hours.

ii. Letter of Intent (LOI)/Undertaking for Consortium Members:

At this EOI stage, a signed Letter of Intent (LOI) or Undertaking among consortium members is sufficient. A formal Joint Venture Agreement will be required later, only if selected, before the contract is finalized. However, the LOI/Undertaking must clearly specify the lead firm of the JV.

iii. Average Monthly Turnover:

The reference to 'average monthly turnover' in Section 6.4 (Point 6) was a typographical error. The correct requirement is the average annual turnover of the past two years.

iv. Annex A-9:

Please note the following corrections in **Annex A-9**:

- a. Termination Notice Period (Clause 4.1.b): 7 days.
- b. Refund Period (Clause 4.1.d): 20 days.

v. Reduction in Performance Security:

The performance security has been reduced from 10% to 5% of the total contract/bid value.

2- NO OTHER CHANGES:

Except as otherwise expressly provided in the Addendum / Corrigendum, all of the terms and conditions of the tender documents remain unchanged.
