ADDENDUM/CORRIGENDUM

1- AMMENDMENTS:

The following amendments and clarifications are hereby issued with reference to **Tender No. 19**. This addendum/corrigendum forms an integral part of the original tender document. All terms and conditions of the original tender document remain unchanged, except as modified by this addendum/corrigendum.

i. Extension of Bid Submission Deadline:

The bid submission deadline has been extended. Bids, prepared in accordance with the instructions given in the tender documents, must now be submitted through the e-Pak Acquisition and Disposal System (e-PADs) on or before 29th December 2025 at 1400 hours. The proposals will be opened on the same day at 1430 hours.

ii. Mandatory Requirements:

There was a typographical error in Sub-clause 4 of clause 6.3 (Mandatory Requirements). The corrected sub-clause 4 of clause 6.3 is as follows:

“Audited financial statements of the Firm for last 03 years having average annual turnover of at least 200 million PKR from consultancy services. In case of JV, all partners collectively can meet the turnover threshold of 200 million.”

iii. Annex A-3:

Please note the following addition in **Annex A-3**:

“3- JV partners jointly and severally undertake that any internal dispute, conflict, claim, dissolution, or disagreement among JV members is their exclusive responsibility and would not involve or create liability for IESCO. If such conflict affects performance, NEPRA can direct IESCO to terminate the agreement without any JV partner's financial or legal claim against IESCO.”

2- NO OTHER CHANGES:

Except as otherwise expressly provided in the Addendum / Corrigendum, all of the terms and conditions of the tender documents remain unchanged.
