## DECISION

1. As per facts of the case, the Respondent, who is a domestic consumer of the Appellant FESCO bearing Ref No.26-13221-0976071 filed an application before the Provincial Office of Inspection, Faisalabad Region, Faisalabad (the POI) on 03.06.2019 and challenged the detection bill of Rs.684,992/- for 34,510 units for the period June 2015 to November 2015 six (6) months charged by the FESCO based on 60% load factor of the connected load. The matter was disposed of by the POI vide decision dated 30.09.2019, wherein the aforementioned detection bill was declared null and void and FESCO was directed to charge 2,691 units for the period June 2015 to November 2015 six (6) months at the rate of 66% slowness of the meter.

2. Through the instant appeal, the POI decision dated 30.09.2019 has been assailed by the FESCO before the NEPRA. After issuing the notice, hearing of the appeal was conducted at the NEPRA Regional Office Lahore on 22.10.2021 in which the learned counsel along with SDO FESCO appeared for the Appellant and no one appeared for the Respondent. At the outset of the hearing, learned counsel for the FESCO informed that the dispute of the billing had been settled between the parties, as such the FESCO did not intend to proceed with the appeal. In support of his averment, learned counsel for the FESCO filed a copy of the letter dated 17.06.2016 showing the out of court settlement between the parties.
3. In view of the above, the appeal is disposed of as withdrawn.
