## ORDER

1. Hearings of the subject Appeal were conducted on 14.09.2024, 02.11.2024, 21.04.2025 and 13.06.2025, for which prior notices were issued to both parties (the Appellant and the Respondent). In furtherance, Zoom link was also shared with the counsel for the Appellant in order to facilitate him for the hearing of the subject appeal, however, neither the Appellant nor his counsel attended the hearings i.e. 14.09.2024, 02.11.2024 and 13.06.2025. In order to meet ends of justice, final opportunity of hearing was given to the Appellant on 16.08.2025, for which notices dated 08.08.2025 were served to both parties. In addition, the counsel for the Appellant was informed through WhatsApp regarding the hearing and Zoom meeting ID was also shared to attend the hearing at 11:00 am. On the given hearing date, again, no one tendered appearance for the Appellant physically as well as through Zoom, whereas SDO represented the Respondent before NEPRA. This whole scenario shows lack of interest on the part of the Appellant in pursuing this appeal despite affording several opportunities for hearings.
2. In view of the above, the appeal is dismissed for non-prosecution in accordance with Regulation 11(1) of the NEPRA (Procedure for Filing Appeals) Regulations, 2012.
