DECISION

1. Through this decision, an appeal filed by Yousaf Khan (hereinafter referred to as the appellant) against the decision dated 27.10.2014 of Provincial Office of Inspection (POI) is being disposed of.
2. As per facts of the case, the respondent is a domestic consumer of K-Electric Ltd (hereinafter referred to as KE) bearing Ref No.AL-119604 with a sanctioned load of 3 kW under A-1R tariff.

3. The appellant filed an application on 25.10.2013 to POI and complained against the arrear bill of Rs. 45,734/- for 2,970 units for the month September 2013. POI announced its decision on 27.10.2014. The operative portion is reproduced below:

"The scrutiny of record, made available to this authority hearing of both the parties and in the light of above findings, this authority reached on conclusion that Irregular bill raised for 2970 units amounting to Rs. 53,540/- for the period from 09.03.2013 to 06.08.2013, is on higher side which should be revised up to 3 months only instead of 05 in the consideration of consumption trained for next corresponding period i.e. 09.05.2013 to 06.08.2013.

The opponents are directed to act in terms of above instructions. accordingly "

4. Being aggrieved with decision dated 27.10.2014, the appellant has filed the instant appeal before NEPRA under section 38 (3) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997 (hereinafter referred to as "the Act").
5. In response to above appeal, the respondent was issued a notice for filing reply/parawise comments which were however not submitted.
6. After issuing notice to both the parties the appeal was heard in Karachi on 11.09.2015 in which Yousaf Khan the appellant appeared in person and KE was represented by Mr. Rafique Ahmed Shaikh General Manager and Ms. Tatheera Fatima Deputy General Manager. During the course of hearing, both the parties agreed for following amicable settlement:

"KE to recover arrears total mounting to Rs. 15,000/- in three equal installments and remaining arrears to be waived off"
