

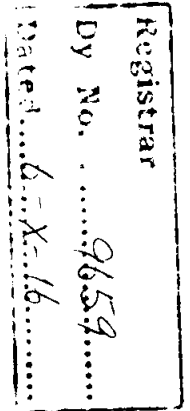

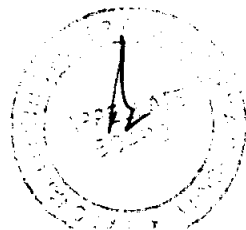

## DECISION

1. As per facts of the case, one Syed Muhammad Amin, being a commercial consumer of K-Electric was charged a detection bill of Rs. 585,262/- for 41,958 units for the period from 08.09.2008 to 07.06.2010 (21 months) owing to some discrepancy of shunt found in the meter. Said action of K-Electric was assailed by the consumer before the Provincial Office of Inspection (POI) who decided the matter vide a decision dated 29.1.2016.
2. The appeal in hand has been filed by K-Electric against the decision dated 29.1.2016. During the course of hearing of the appeal and examining the record, it revealed that the appeal is filed against Mrs. Seema Irfan and thereafter the name of Syed Muhammad Amin is mentioned in bracket. As per record, the complaint before POI was filed by Syed Muhammad Amin but in the impugned decision, Mrs. Seema Irfan is being shown as respondent. Therefore, there seems to be an ambiguity in the impugned decision and we find difficulty in ascertaining as to who is the respondent; notice of appeal thereof could be issued.

3. For the foregoing reason, without going into the merits of the case, the impugned decision is set aside and the case is remanded back to the POI for rendering appropriate decision clearly identifying the name of the complainant/respondent.
