## DECISION


1. As per facts of the case, a person namely Arif Ullah Khan challenged the detection bill amounting to Rs. 88,370/- for 5,716 units for the period from 20.12.2013 to 19.06.2014 charged to the domestic connection with Ref. No. AL-606123 vide the application dated 08.09.2014 before the Provincial Office of Inspection, Karachi Region-II, Karachi (POI). POI disposed of the matter vide its decision dated 04.05.2016.
2. K-Electric being aggrieved with the decision of POI dated 04.05.2016 (impugned decision) has filed the instant appeal. During the hearing of the appeal on 28.11.2016 and from examination of the record placed before us, it is observed that the application against the detection bill was filed before POI by Mr. Arif Ullah Khan but in the impugned decision as well as in the instant

appeal name of Mrs. Jehan Ara Begum is also included as the respondent within brackets. Due to this ambiguity it is difficult to determine as to who is the actual respondent to whom notice of the appeal may be issued.

3. In view of reason mentioned in foregoing paragraphs, without going into merit of the case, the matter is remanded back to POI for deciding the matter afresh with clear description of the name of the parties.
4. The appeal is disposed of in above terms.
