DECISION

- 1. As per facts of the case, a person namely Mr. Sultan filed an application before the Provincial Office of Inspection, Karachi Region-II, Karachi (POI) on 07.02.2015 and challenged the excessive billing against domestic connection bearing Ref. No. LA-904717. The matter was disposed of by POI vide its decision dated 04.05.2016.
- 2. K-Electric being aggrieved with the decision of POI dated 04.05.2016 (impugned decision) has filed the instant appeal. It is noted that in the impugned decision as well as in the instant appeal, name of M. Hanif appears within brackets along with Mr. Sultan as respondent. This has created confusion in determining as to who is the actual respondent for issuing notice of the appeal etc.

- 3. In view of above reason, without going into merit of the case, the impugned decision is set aside and matter is remanded back to POI for deciding the matter afresh clearly specifying the name of the parties.
- 4. The appeal is disposed of in above terms.
