

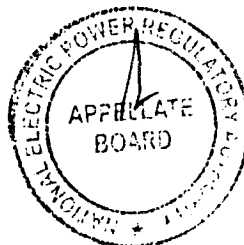

## DECISION

1. This decision shall dispose of an appeal filed by K-Electric against the decision dated 02.12.2016 of Provincial Office of Inspection Karachi Region-II Karachi (hereinafter referred to as POI). As per facts of the case the respondent is a commercial consumer of K-Electric having sanctioned load of 1 kW and governed under tariff A-2c. The respondent received a bill of Rs. 435,001/- in the month October 2015 which was assailed before POI on 03.11.2015. POI accepted the application of the respondent and directed to cancel the entire average billing and revision of the same on minimum

charges basis.

2. K-Electric being aggrieved with the POI decision dated 02.12.2016 has filed the instant appeal under section 38 (3) of NEPRA Act 1997. A notice of the appeal was issued to the respondent for filing reply/parawise comments but no reply/parawise comments were filed by the respondent.
3. Notice was issued and hearing was conducted in Karachi on 10.04.2017 in which no one appeared for the respondent and Ms. Tatheera Fatima Deputy General Manager and other officials represented K-Electric. At the outset of the hearing, the representative of K-Electric apprised that an amicable settlement outside the court between the parties was reached and as such K-Electric was not interested to pursue the appeal any more before NEPRA.
4. In consideration of above, the appeal is dismissed as withdrawn.
