

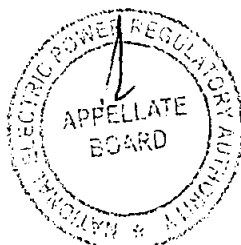

DECISION

1. As per facts of the case, a person namely Nawaz Ahmed filed a complaint before the Provincial Office of Inspection, Karachi Region-I, Karachi (POI) on 09.03.2017 and challenged the irregular bill of Rs. 264,967/ for February 2017 against the commercial connection bearing Ref. No. AL-047171 with sanctioned load of 4 kW under tariff A2-c. The matter was disposed of by POI vide its decision dated 14.04.2017.

2. K-Electric being aggrieved with the decision of POI dated 14.04.2017 (impugned decision) has filed the instant appeal under Section 38 (3) of NEPRA Act 1997. It is noted that in the impugned decision as well as in the instant appeal, name of F. M. Mistri appears within brackets along with Nawaz Ahmed as the respondent. This has created confusion in determining as to who is the actual respondent for issuing notice of the appeal etc.
3. In view of the above, without going into merit of the case, the impugned decision is set aside and matter is remanded back to POI for deciding the matter afresh clearly specifying the name of the parties.
4. The appeal is disposed of in above terms.
