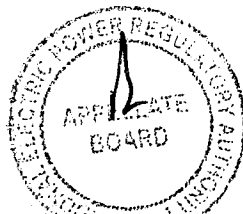

## DECISION

1. As per facts of the case, the respondent is domestic consumer of the appellant K-Electric bearing Ref No. LA-560911, filed application before Provincial Office of Inspection/Electric Inspector Karachi Region-II, Karachi (hereinafter referred to as POI) on 19.01.2016 and challenged the detection bill of Rs. 106,084/- for 5,331 units for the period 06.05.2015 to 03.11.2015 charged in January 2016 on the basis of connected load.
2. The matter was disposed of by POI vide its decision dated 30.09.2016, wherein the

above detection bill was cancelled. Through the instant appeal, POI decision dated 30.09.2016 has been assailed. Notice was issued and hearing of the appeal was conducted in Karachi on 20.03.2017 in which both the parties entered their appearance. At the outset of hearing, it was stated by representative for K-Electric that the matter was amicably settled outside the court between the parties and as such K-Electric was not interested to pursue the appeal any more. An application for withdrawal of the appeal was also filed by K-Electric before us.

3. Foregoing in consideration, the appeal is dismissed as withdrawn.
