

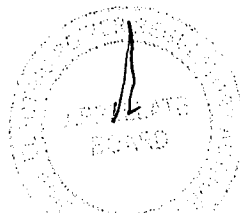

DECISION

1. This decision shall dispose of the appeal filed by K-Electric against the decision dated 08.08.2017 of Provincial Office of Inspection, Karachi Region-I, Karachi (hereinafter referred to as POI).
2. As per facts of the case, the respondent who is a domestic consumer of the appellant K-Electric bearing Ref No.AL-049040 filed application before POI and challenged a detection bill of Rs.29,230/- of 2,407 units for the period 14.07.2013 to 14.01.2014 charged by K-Electric. The matter was disposed of by POI vide its decision dated

08.08.2017, wherein the above detection bill was declared null and void.

3. Through the instant appeal, POI decision dated 08.08.2017 has been assailed. After issuing notice, hearing of the appeal was conducted in Karachi on 30.12.2017 in which K-Electric officials participated but there was no representation by the respondent. At the outset of hearing, representative for K-Electric disclosed that some compromise with the respondent has been effected, therefore, it did not intend to proceed further with the appeal. In support of its version, K-Electric placed a document signed by the respondent for the amicable settlement of the disputed bill.
4. In view of the above, the appeal is dismissed as withdrawn.
