

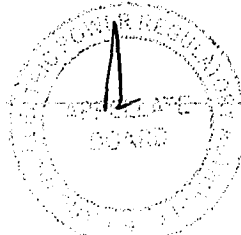

DECISION

1. This decision shall dispose of the appeal filed by K-Electric against the decision dated 18.08.2017 of Provincial Office of Inspection, Karachi Region-II, Karachi (hereinafter referred to as POI).
2. As per facts of the case, the respondent who is a domestic consumer of the appellant K-Electric bearing Ref No. AL-521071 filed a complaint before POI on 22.01.2014 and challenged the assessed bills amounting to Rs.73,260/-. The matter was disposed of by

POI vide its decision dated 18.08.2017, wherein the assessed/average billing for the period from January 2012 and onwards was cancelled and K-Electric was directed to revise the same as per actual meter reading.


3. Through the instant appeal, POI decision dated 18.08.2017 has been assailed. After issuing notice, hearing of the appeal was conducted in Karachi on 30.12.2017 in which both the parties entered their appearance. During the course of hearing, the respondent accepted the offer of K-Electric to pay an amount of Rs.22,725/- against the total disputed bill of Rs.82,725/- till to date. Hence K-Electric expressed its intention not to pursue the appeal any more.
4. In view of mutual settlement inter se the parties, the appeal is dismissed as withdrawn.
