#### **ORDER**

- 1. After issuing notice, a hearing in the matter was conducted at the NEPRA Regional Office Lahore on 04.02.2021 wherein no one represented the Respondent LESCO and Syed Abdur Reman Hashmi the Appellant appeared in person. The Appellant informed that the bill of Rs.25,325/- was charged by the LESCO in December 2021, which has been corrected by the LESCO for an amount of Rs.6,539/- after withdrawing the disputed amount of Rs.18,786/-. According to the Appellant, the revised bill has been paid and supplied a copy of the paid bill for December 2021. The Appellant apprehended that is supply might be disconnected by the LESCO for the disputed arrears as such the LESCO may be directed not to disconnect the connection of the premises on account of non-payment of the disputed arrears.
- 2. In view of the facts stated above, the LESCO is restrained from the disconnection of
