ORDER

1. Hearing of the subject Appeal was initially fixed on 12.06.2025, for which notices dated 05.06.2025 were issued to both parties (the Appellant and the Respondent). On the given hearing date, learned counsel for the Appellant tendered appearance and no one represented the Respondent. During scrutiny of the record, supporting documents were not found. NEPRA adjourned the matter vide order dated 25.06.2025 with the following directions:

"In view of the above, the hearing is adjourned till the next date with the direction to the Appellant to ensure the attendance of officials well versed with the case along with the requisite documents i.e. PITC data for the years 2021 to 2025, MCO, detection proforma, etc. It may be noted that no further adjournment would be allowed, and the matter will be decided on the basis of available record in accordance with law."

In order to provide the final opportunity of hearing to both parties, hearing was again fixed at NEPRA Regional Office Lahore on 15.08.2025, for which notices dated 08.08.2025 were issued to both parties. On the given hearing date, again, no one tendered appearance for both the Appellant and the Respondent before NEPRA, this shows lack of interest on the part of Appellant in pursuing this appeal.
