## DECISION

This decision shall dispose of the complaint filed by M/s Anwar Steel Furnace through Mr. Mustafa Kamal Advocate (hereinafter referred to as the "Complainant" or "Petitioner") against Gujranwala Electric Power Company Limited (hereinafter referred to as the "Respondent" or "GEPCO"), under Section 39 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (hereinafter referred to as the "NEPRA Act").

- 2. Brief facts of the case are that the Complainant filed a complaint before NEPRA received on July 25, 2025 regarding charging of fixed charges by GEPCO in the bill issued for the month of June 2025 in the light of tariff determination issued by NEPRA on July 11, 2024 and requested that the said tariff determination may be declared illegal alongwith revision of bill.
- 3. The matter was taken up with GEPCO for submission report and a hearing was held at NEPRA Head Office, Islamabad. The hearing was attended by GEPCO official(s) only whereas the Complainant remained absent. During the hearing, GEPCO officials provided a copy of orders of the Honorable Lahore High Court, Lahore passed against W.P. No. 18254/2025 wherein the Court has directed NEPRA for disposal of the complaint expeditiously. During the hearing and scrutiny of documents i.e. complaint/petition it was observed that the Complainant has challenged the tariff determination dated July 11, 2024 of the Authority and consequently fixed charges imposed by GEPCO in the electricity bill(s).
