

Subject: DECISION IN THE MATTER OF MOTION FOR LEAVE FOR REVIEW FILED BY MR. UMER S/O MALIK JAVED AGAINST THE DECISION OF NEPRA REGIONAL OFFICE KARACHI REGARDING DETECTION BILL (CONSUMER NO. LA-193459)

This decision shall dispose of a motion for leave for review of Mr. Umer (hereinafter referred to as the "Complainant") against the decision of NEPRA Regional Office, Karachi dated August 30, 2024 in the matter of complaint filed by Mr. Umer against K-Electric (hereinafter referred to as the "Respondent" or "KE"), under Section 39 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (hereinafter referred to as the NEPRA Act).

2. Brief facts of the case are that NEPRA received a complaint wherein the dispute agitated by the Complainant was that KE has charged detection bill without any justification. The Complainant requested NEPRA to intervene in the matter and direct KE to withdraw the detection bill. The matter was taken-up with KE for submission of parawise comments/report. In response KE reported that as per the site inspection report dated January 04, 2024, a discrepancy of 'Extra Phase Use' was found and connected load was found to be 2.1 kW. KE added that the consumer has been charged detection bill amounting to Rs.50874/- on the connection bearing Consumer No. LA-193459. The report of KE was sent to the Complainant for information/comments. The Complainant raised observations over the report of KE.

- 3. In order to proceed further into the matter, hearings were held at NEPRA Regional office Karachi which were attended by both the parties i.e. (KE and the Complainant) in person.
- 4. In light of written/verbal arguments of the parties, applicable law, the Complainant vide NEPRA Regional Office Karachi decision dated August 30, 2024 was informed that KE has charged the detection bill of Rs.50,874/- on the basis of sufficient evidence and the same is liable to be paid. Accordingly, further proceedings in the matter were closed.
- Office, Karachi dated August 30, 2024. The review filed by the Complainant was considered and accordingly a hearing was held on January 06, 2025 which was attended by both the parties. Subsequently, a joint site inspection was also conducted on January 06, 2025 in presence of both the parties. It has been observed that the Complainant's premises comprises of about 850 sq. feet flat/apartment on 5th floor of a multistorey building/apartment. The Complainant's electricity meter found installed at ground floor at common area along with other electricity meters. The connected load of the premises has been observed as 3.45 kW against the connection bearing consumer no. LA-193459. In order to decide the matter, another hearing was held on May 22, 2025 wherein both parties participated and case was discussed in detail.
- 6. The motion for leave for review is disposed of in the following terms:
 - i. The instant matter pertains to charging of detection bill amounting to Rs.50,874/- by KE to the Complainant on the connection bearing consumer No. LA-193459 having A-1 tariff.
 - ii. KE has charged the detection bill to the Complainant on the basis of extra phase use for the period from July 2023 to January 2024 on the allegation of direct use of electricity.
 - iii. Moreover, KE has issued the said detection bills without following the procedure prescribed in clause 9.1 of Consumer Service Manual (CSM) which provides a procedure for charging of detection bill.
 - iv. The electricity consumption of the Complainant's account is mentioned below:

The electricity consumption of the Complainant's connection shows that the consumption of the Complainant is on lower side as compared with the consumption observed during the corresponding months of the previous year. Therefore, the allegation appears to lack merit when viewed against the historical data, undermining the claim of extra phase in use

- v. Furthermore, the representatives of KE presented evidence of an alleged punctured wire. However, they failed to substantiate the claim of electricity theft, as the wire in question was connected to the outgoing terminal of the Complainant's electricity meter. Any hook connection from the meter's outgoing side would still be recorded by the meter. In contrast, if such a connection were made on the incoming side, it would bypass the meter and constitute an electricity theft.
- 7. Foregoing in view, the review filed by the Complainant is accepted and the decision of NEPRA Regional Office, Karachi dated August 30, 2024 is modified. Accordingly, KE is directed to withdraw the detection bill charged against the connection bearing consumer No. LA-193459/-. The case is disposed of in the above terms.
