AGAINST K-ELECTRIC LIMITED REGARDING DETECTION BILL
(CONSUMER NO. LC-042726)

This decision shall dispose of the Complaint filed by Mr. Shafique Tabassum, H. No. 3862, Gulshan-e-Ghazi, Block No. A, Hazara Colony, Baldia Town, Karachi, (hereinafter referred to as "the Complainant") against K-Electric Limited (hereinafter referred to as the "Respondent" or "KE"), under Section 39 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (hereinafter referred to as the "NEPRA Act").

2. Brief facts of the case are that NEPRA received a complaint wherein the dispute agitated by the Complainant was that KE has charged detection bills and requested NEPRA to intervene in the matter & direct KE to withdraw the detection bill. The matter was taken-up with KE for submission of parawise comments/report. In response, KE reported that the meter installed at Complainant's premises was found to be defective owing to display off issue. The said meter has been duly replaced and a supplementary bill for two previous month's i.e March 2024 & April 2024 has charged to the Complainant. Further KE added that a discrepancy of d defective owing to display off was reported. KE added that the consumer has been charged detection bill amounting to Rs.19,229/- on the connection bearing Consumer No. LC-042726. The report of KE was sent to the Complainant for information/comments. The Complainant raised observations over the report of KE.

- 3. In order to proceed further into the matter, a hearing was held at NEPRA Regional office Karachi on July 16, 2025 which was attended by both the parties i.e. (KE and the Complainant) in person wherein the matter was discussed in detail.
- 4. The case has been examined in detail in light of the record made so available by the parties, arguments advanced during the hearing and applicable law. The following has been observed:
 - i. The instant matter pertains to charging of detection bill amounting to Rs.19,229/- to the Complainant on the connection having consumer No. LC-042726 having tariff A1R.
 - ii. KE is of the view that the detection bill amounting to Rs. 19,229/- for the months of March 2024 & April 2024 have been charged on connected load due to discrepancy of faulty meter.
- iii. KE submitted meter department report dated April 18, 2024 having remarks a "Terminal strip and main cover seal caps found intact. On power meter display found stuck. Low battery signal. Meter malfunctioning on testing bench".
 - iv. Further it is observed that KE has charged the said detection bill on higher side.
- 5. Foregoing in view, KE is directed to revise the detection bill amounting to Rs.19,229/- charged to the Complainant on the same connection on the basis of average consumption observed during last 11 months or same month last year whichever is higher. A report in this regard be submitted within twenty (20) days, positively.
