Reference is made to the following:

- i. NEPRA Complaints Resolution Committee (CRC)'s decision dated September 04, 2024.
- ii. Complainant's letter dated May 16, 2025 regarding the subject matter.
- iii. Hearing Held on June 17, 2025 regarding the subject matter.
- 2. KE was directed vide the above referred CRC decision dated September 04, 2024, to provide a regular electricity connection to the Complainant as per the provisions of the Consumer Service Manual (CSM), after completion of all requisite codal formalities. However, the Complainant, through the referenced letter dated May 16, 2025, again approached this office and informed that the matter remained unresolved, as no regular connection had been provided by KE.
- 3. Accordingly, a hearing was held on June 17, 2025, wherein KE informed that it was willing to provide a regular electricity connection to the Complainant; however, the Complainant had not yet constructed a proper building structure. During the hearing, KE presented a video of the Complainant's premises, which showed a temporary setup consisting of a single room and a kitchen, a tent setup for living, lacking basic amenities and thus was deemed insufficient for provision of a regular connection. It was also observed that no proper internal wiring had been carried out, and no approved building plan is available.

in light of the foregoing, a regular electricity connection cannot be extended to the Complainant at this stage. The decision of CRC dated September 4, 2024 is modified accordingly. KE shall provide regular connection to the Complainant once the building is constructed and all codal formalities are completed. Further proceedings in the matter are being closed in the above terms.
