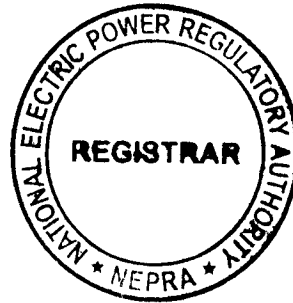



The Authority hereby grants **Generation** Licence to Mr. Zubair Khan, for 4.80 KW photovoltaic solar based distributed generation facility, having consumer reference number 06N0399300-3409, located at House # 1897, Road-1, Phase-III, Bahria Town, Islamabad under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
