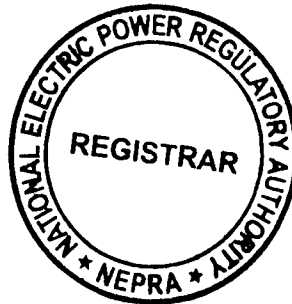



No. DGL/4269/2020

The Authority hereby grants Generation Licence to Ch Muhammad Yasin, for 3.80 kW photovoltaic solar based distributed generation facility, having consumer reference number 02N0104200-863, located at House # 125, Street # 06, Phase-1, Bahria Town, Islamabad under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 
