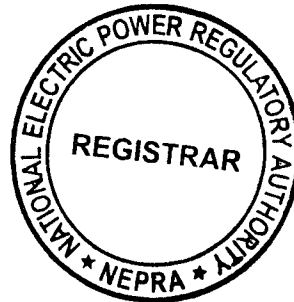



The Authority hereby grants Generation Licence to Mrs. Atiqa Ibrahim, for 6.20 KW photovoltaic solar based distributed generation facility, having consumer reference number 221001368200-13456, located at House # 1049-C, Street # 49, Phase-VIII, Bahria Town, Rawalpindi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
