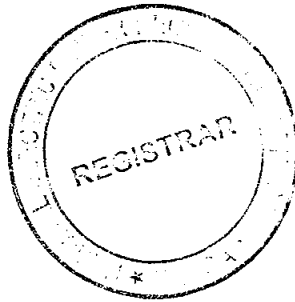



The Authority hereby grants Generation Licence to Syed Sajid Rizvi, for 8.70 KW photovoltaic solar based distributed generation facility, having consumer reference number 08N0571800-4875, located at House # 761, Road-C, Phase-IV, Bahria Town, Islamabad under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
