

The Authority hereby grants Generation Licence to Mrs. Sana Zubair, for 11.00 kW photovoltaic solar based distributed generation facility, having consumer reference number 05N0334200-2864, located at House # 109, Street # 04, Phase-III, Bahria Town, Islamabad under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
