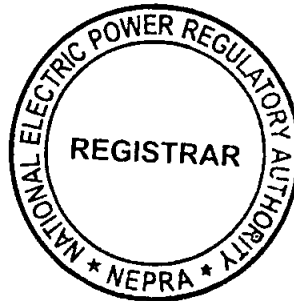


The Authority hereby grants Generation Licence to Mr. Altaf Hussain, for 11.88 KW photovoltaic solar based distributed generation facility, having consumer reference number 221001493400-14744, located at House No. 174, Street No. 7, Zone-I, Garden City, Phase-VII, Bahria Town, Rawalpindi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
