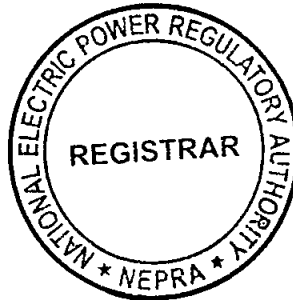


The Authority hereby grants Generation Licence to Mr. Muhammad Ameen Sharif, for 12.60 KW photovoltaic solar based distributed generation facility, having consumer reference number 10N0751900-10353, located at House No. 88, Road A, Phase V, Bahria Town, Islamabad under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
