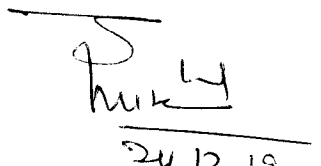

The Authority hereby grants Generation Licence to Mrs. Ayesha Khalil, for 4.62 KW photovoltaic solar based distributed generation facility, having consumer reference number 50445, located at House # 445-E, DHA Phase-XII, Multan Road, Lahore under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 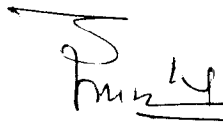
