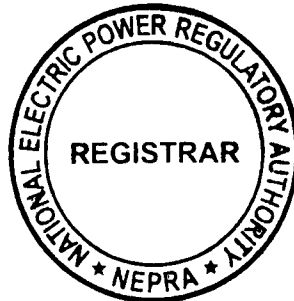

The Authority hereby grants Generation Licence to Mr. Irfan Ahmed, for 10.08 kW photovoltaic solar based distributed generation facility, having consumer reference number 60142, located at House # 142-F, DHA Phase-XII, Multan Road, Lahore under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 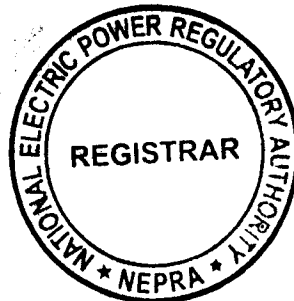
