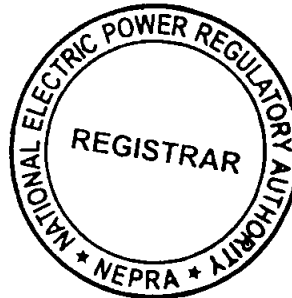



The Authority hereby grants Generation Licence to Mrs. Faiza Israr Malik, for 30.03 KW photovoltaic solar based distributed generation facility, having consumer reference number 40018-16, located at House # 18-D16, DHA Phase-XII, Lahore under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
