

The Authority hereby grants Generation Licence to Mr. Waseem UI Hassan, for 12.54 KW photovoltaic solar based distributed generation facility, having consumer reference number 30126, located at House # 126-C, DHA Phase-XII, Multan Road, Lahore under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. This Licence is valid up to 27<sup>th</sup> day of July 2027.
