

The Authority hereby grants Generation Licence to Mr. Khalid Mehmood Choudhary, for 21.60 KW photovoltaic solar based distributed generation facility, having consumer reference number 9024, located at House # 24-J, DHA Phase-XII, Multan Road, Lahore under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
