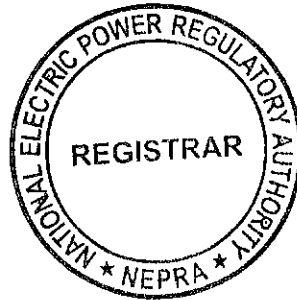

No. DGL/4086/2020

The Authority hereby grants Generation Licence to Mr. Faisal Mehmood, for 18.40 kW photovoltaic solar based distributed generation facility, having consumer reference number 6015-1, located at House # 15-F1, DHA Phase-XII, Multan Road, Lahore under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. This Licence is valid up to 12th day of March 2027.

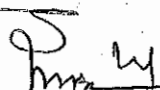

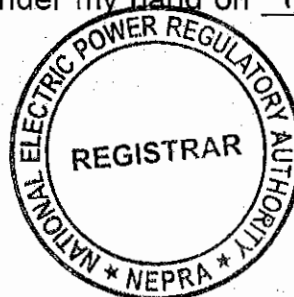
