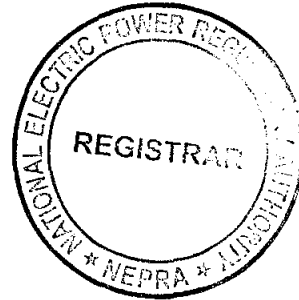



The Authority hereby grants Generation Licence to Mr. Attaullah Akhtar, for 13.77 KW photovoltaic solar based distributed generation facility, having consumer reference number 90206, located at House # 206-J, DHA Phase-XII, Lahore under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
