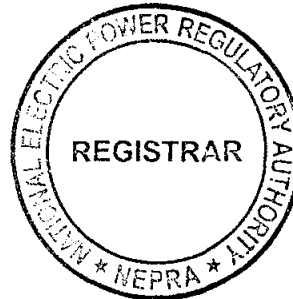



The Authority hereby grants Generation Licence to Mr. Usman Khursheed, for 5.53 KW photovoltaic solar based distributed generation facility, having consumer reference number 2064, located at House # 64-B, DHA Phase-XII, Lahore under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
