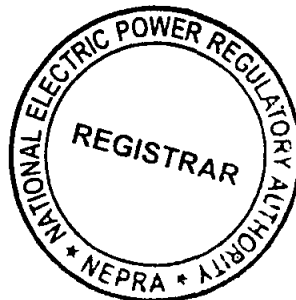

The Authority hereby grants Generation Licence to Mr. Muhammad Jahangir, for 5.280 KW photovoltaic solar based distributed generation facility, having consumer reference number 40149, located at House No. 149-D, DHA Phase-XII (EME), Lahore under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
