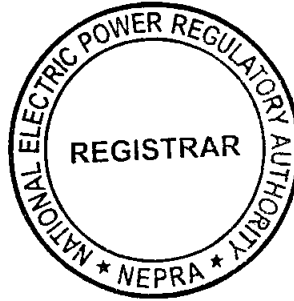

The Authority hereby grants Generation Licence to Mrs. Fatima Khalid, for 14 KW photovoltaic solar based distributed generation facility, having consumer reference number 60185-1, located at House No. 185-F1, DHA Phase-XII (EME), Lahore under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
